PSHE

At Lord Scudamore, we teach Personal, Social, Health Education as a whole school approach to underpin children's development as people and because we believe that this also supports their learning capacity.

The Jigsaw Programme occers us a comprehensive, carecully thoughtthrough Scheme oc Work which brings consistency and progression to our children's learning in this vital curriculum area. The overview oc the programme can be seen on the school website.

This also supports the "Personal Development" and "Behaviour and Attitude" aspects evaluated under the Ocsted Inspection Framework, as well as significantly contributing to the school's Saceguarding and Equality Duties, the Government's British Values agenda and the SMSC (Spiritual, Moral, Social, Cultural) development opportunities provided cor our children. **Statutory Relationships and Health Education**

"The Relationships Education, Relationships and Sex Education and Health Education (England) Regulations 2019, made under sections 34 and 35 of the Children and Social Work Act 2017, make Relationships Education compulsory for all pupils receiving primary education...They also make Health Education compulsory in all schools except independent schools. Personal, Social, Health and Economic Education(PSHE) continues to be compulsory in independent schools." Here, at Lord Scudamore we value PSHE as one way to support children's development as human beings, to enable them to understand and respect who they are, to empower them with a voice and to equip them for life and learning.

We include the statutory Relationships and Health Education within our whole-school PSHE Programme.

To ensure progression and a spiral curriculum, we use Jigsaw, the mindcul approach to PSHE, as our chosen teaching and learning programme and

tailor it to children's needs. The mapping document: Jigsaw 3-11 and statutory Relationships and Health Education, jigsaw-3-11-and-she-<u>overview-mappdc (windowsnet)</u>, shows exactly how Jigsaw and therefore our school, meets the statutory Relationships and Health Education requirements.

This programme's complimentary update policy ensures we are always using the most up to date teaching materials and that our teachers are well-supported.

What do we teach when and who teaches it?

Whole-school approach

Jigsan covers all areas of PSHE for the primary phase including statutory Relationships and Health Education. The table below gives the learning theme of each of the six Puzzles (units) and these are taught across the school; the learning deepens and broadens every year.

At Lord Scudamore we allocate 1 hour to PSHE each week in order to teach the PSHE knowledge and skills in a developmental and age-appropriate way. These explicit lessons are reincorced and enhanced in many ways: Assemblies, our praise and reward system, Learning Charter, through relationships child to child, adult to child and adult to adult across the school. We aim to live what is learnt and apply it to everyday situations in the school community.

Class teachers deliver the weekly lessons to their own classes.

Concidentiality

During PSHE sessions there are many circumstances in which disclosures regarding personal incormation may be made to stacc. The collowing points should be considered:

- All members of the school community need to be clear about the rules of confidentiality. Information about children should not be passed on indiscriminately.
- Teachers are not able to occer children or their parents' unconditional concidentiality. It stack receive incormation about behaviour likely to cause harm to the child or to others, they must pass it on to the Saceguarding Manager where relevant, collowing the school's child protection procedures.
- Teachers should make it clear to children that it is not possible to keep all incormation concidential and that it is sometimes necessary to

tell someone else. However, the children need to know when this has to happen, what will be done with the incormation, and who will have access to it.

- In the case of illegal activity, action should be taken in the best interests of the child. This does not necessarily involve informing the police. Teachers are not statutorily required to inform the police about illegal drug activity, for example. The school's police liaison officer will provide guidance about specific instances.
- Where outside agencies and others provide support for the PSHE and citizenship provision, they must be made aware of, and abide by this policy about disclosures and confidentiality. However, they may also have a role in providing advice and support directly to young people. The boundary between these two roles must be agreed with the school and the distinction, in terms of right to confidentiality, must be made clear to the children.
- Other processions are bound by their own codes of confidentiality. For example, health processionals, such as the school nurse, are bound by the medical code of confidentiality in their work with children and young people.
- In lessons, teachers should establish from the beginning that it is inappropriate to disclose some personal information. Children need to be clear about not putting pressure on one another to answer questions about their own experiences. This also applies to any adult in the school.

When teaching PSHE we adhere to our schools Sazeguarding and Child Protection policies when necessary. All children are well established in the knowledge that they are able to speak with a trusted adult whenever needed. Any disclosures are reported to the school DSL in the correct timegrame.
